## ANNOUNCEMENTS (6:01 PM)

Chair Reeves welcomed new Commissioner Garone. He also thanked Commissioner Papano for being a part of the Planning Commission and expressed how much he will be missed.

Grumbach made the following announcements:

1) Continued discussion on updates to drainage and grading regulations

Grumbach briefed the Commissioners that he and Commissioner Nelson met with the drainage consultants mentioned at the previous meeting. They provided helpful information on the City's update efforts. Grumbach noted they gave a contact at the University of Washington he would follow-up on for possible help looking at the feasibility of storm water infiltration.

Grumbach summarized the discussion from the prior meeting. He distributed an updated draft of regulations and reviewed the changes with the Commissioners. City Engineer Consultant, Chris Ruiz, briefed the Commissioners on the differences between the current regulations and updated regulations. Grumbach and Ruiz responded to questions from the Commissioners. The Commissioners expressed overall satisfaction with the drafted updates. Grumbach said he would bring the final draft on the regulations to the next meeting.

 Continued Discussion on Comprehensive Review of MMC 20.30.020 – Sign Code

Grumbach began by recapping the policy discussion from the last meeting on whether to increase signage standards for non-commercial signs to those of business establishments, or to decrease the business establishment signage to those of non-commercial signs. He also reminded the Commissioners that the goal of the sign regulations is to protect the residential setting of the City. Grumbach then began to lead the Commissioners through a review of the draft.

A discussion ensued pertaining to the following sections of 20.30.20:

- A: Purpose
- B: General provisions
- C: Prohibited signs
- D: Exempt signs
- E: Application of sign development standards

F: Non-residential sign development standards

Table 20.30.020(F)(1) Non-residential Permanent Sign Development Standards Table 20.30.020(F)(2) Non-residential Temporary Sign Development Standards

During the discussion Grumbach responded to questions about content vs design and size, defective signs, signs in city parks, traffic control signs and conditional use permits.

The Commissioners discussed the advantages and disadvantages of requiring conditional use permits for signs. There was a consensus to remove the requirement for a conditional use permit for signs. There were also several suggestions and comments regarding minor alterations to the code language.

The review of Table 20.30.020(F)(1), Non-residential Commercial Sign Development Standards, launched a very extensive discussion regarding the maximum number of signs per public street frontage. Due to the time the Commissioners agreed to table this discussion. The Commissioners began discussion on Table 20.30.020(F)(2), but due to the hour, tabled the discussion until the next meeting.

3) Discussion on upcoming meetings

Grumbach briefed the Commissioners on upcoming work items. With the upcoming agendas full due to construction mitigation plan hearings, the Commissioners agreed to hold special meetings to continue making progress on the sign code. Grumbach will send emails to Commissioners to coordinate a date and time.
