MOTION DOUD / SECOND NELSON TO APPROVE THE MINUTES OF THE OCTOBER 27, 2015 PLANNING COMMISSION MEETING. APPROVED 6 – 0. (6:07 PM)

PUBLIC HEARINGS

There was no public hearing.

OTHER BUSINESS (6:08 PM)

1) <u>Proposed Housekeeping Amendments to the Unified Development Code</u> (6:08 PM)

A discussion on the proposed Housekeeping Amendments began. Grumbach stated that although the Planning Commission has not held a public hearing yet on the UDC Housekeeping Amendments, the Commissioners could still take action tonight. He further explained that should the Commissioners decide to move forward tonight then the public hearing would be held at the City Council level. Grumbach went on to answered questions and further clarified the amendments.

2) 2016 Planning Commission Work Program Discussion (6:50 PM)

Grumbach summarized the Commission's 2015 accomplishments. The Commissioners then began discussing the 2016 work plan. After discussion there was consensus among the Commissioners to prioritize the list as follows:

- 1. Sign Code
- 2. Grading and Drainage Regulations
- 3. Home Occupation Home Businesses
- 4. Construction Mitigation Plan Review and Update
- 5. Bonus Structural Coverage Based on height
- 6. Comprehensive Plan Subject to funding
- 7. Wireless Communication Code Amendments
- 8. Zoning Incentives for Sustainability

There was an inquiry by the Commissioners on sidewalks and crosswalks. Michael Sauerwein, City Manager, was in the audience and responded by remarking on the City's vision of a 'Walkable Medina Plan,' which includes improvements such as installing new and extending existing sidewalks, adding crosswalks and moving utilities underground. He stated this is a ten year plan and there would be more detailed information in 2016.

Commissioner Doud commented on the 520 project, asking for information on any milestones that may have been reached. Grumbach stated he would update the Commission on the 520 project throughout the year during their future meetings.

Chair Reeves expressed his interest in promoting green development. Other Commissioners echoed Chair Reeves. Grumbach responded that there are specific groups that can help educated the Commissioners on this subject. He stated he would look into scheduling a presentation for a future Planning Commission Meeting.
